Meet Archie

When Archie started to show signs of a common viral infection, doctor's believed that it was just something going around day care.

But, with his symptoms getting worse, his parents decided to take action.

After arriving at the emergency department, Archie was admitted quickly and went through a series of tests including an x-ray.

The results showed that Archie had severe pneumonia and group A streptococcal septic shock. His little body was shutting down.

Mum, Sarah says

"being able to stay at the House has made a world of difference to us. As our son was in such a critical condition for weeks, we were able to be by his bedside all day."

Meet Eli

Eli was diagnosed with Acute Lymphoblastic Leukemia.

His family had relocated from their home on the far south coast of NSW to ensure Eli could receive the urgent care he needed.

For the next nine months, they called Ronald McDonald House in Randwick their home.

Dakota, Eli's mum says

"I don't know what we would have done if the House didn't exist, as we live too far... to travel back to the hospital every day. We would have had to stay in a cheap hotel and get local jobs, instead of being present for Eli."

How do I leave a gift in my will?

Including Ronald McDonald House Charities Sydney in your Will is easy. If you already have a Will, then all you need to do to join our family and leave a Legacy of Love is to add a codicil, which is a short legal amendment to your existing Will.

If you do not have a Will, all you need is our ABN 29 907 192 147 and registered name – Ronald McDonald House Charities Sydney.


If you decide to include Ronald McDonald House Charities Sydney in your Will, there are three types of gift you can consider:


- · A 'monetary gift' is a fixed dollar amount
- A 'specific gift' is a possession or item (such as shares or property).
- A 'residuary gift' is a percentage of the residue of your estate once your other wishes have been carried out

Example of wording:

I give to Ronald McDonald House Charities Sydney ABN 29 907 192 147 of 149 - 151 Barker Street Randwick NSW 2031 a gift of (insert your choice of a specific sum or percent share of your residuary estate) for its general purposes.
